



the Foundation set itself apart with its reach and commitment to Lamèque Hospital and CHC. We are so appreciative of the commitment of a community that continues to support our foundation despite the pandemic-related challenges. We firmly believe that our health care has never been so important.



Among the many achievements of the past year, it was possible to invest **\$ 56 740** to support the following sectors:

- \$43 027 patient care, diagnostic, treatment and follow-up services (76 %);

- \$13 163 specialized regional services and cancer-related services (23 %);

- \$550 development and training (1 %).

The success of our campaigns is the result of the huge generosity of the community and the commitment of the volunteers who participate in organizing activities such as the Roses Radiothon and the Northern Star.
